PHAUNOS ANNOUNCES POPLAR PROJECT NEARING COMPLETION

20 December 2007 - Phaunos Timber Fund Limited ("Phaunos") announced today that its Greenwood Tree Farm investment, located in the US Northwest, is nearing completion. The investment, a co-venture with other institutional investors, consists of an integrated plantation and sawmill project. To date, four plantations have been acquired, all located in the northwestern US, and totaling 35,000 acres planted with high-grade hybrid poplar. The specially designed sawmill is scheduled for completion in the spring 2008.

"This is a unique asset in the United States," said Liane Luke, Chief Timber Officer of Phaunos. "By integrating the processing facility with the plantations, we can reduce costs and increase productivity, with more reliable end product. Further, the investment is designed to align our interests with those of our operating and marketing partners." Phaunos committed US\$30 million and owns 17% of the project, which was organized earlier in 2007.

FSC certification has been completed for the first plantation purchased. FSC certification for the three remaining plantations, which were purchased later in the year, is in process and anticipated in the near future.
